BACKGROUND: Shepherds Dene is the Retreat House for the Dioceses of

Durham and Newcastle, being initially gifted to the Diocese of Newcastle in 1946 and shared with the Diocese of Durham for the last 40 years. Its vision is to be a Retreat House in the Christian tradition offering guests from all denominations, faiths and none, a place for reflection and

rest.

JOB SUMMARY: To ensure that Shepherds Dene Retreat House and the

Coach House Cottage are clean and tidy to the highest standards. To act as part of the welcome team ensuring that guests have a trouble free stay. To contribute to the

Christian ethos of the house.

MAIN DUTIES AND RESPONSIBILITIES:

House keeping duties

- To prepare and clean bedrooms, meeting rooms and bathrooms for guests
- To ensure all communal areas are regularly cleaned and kept to a high standard of cleanliness and tidiness.
- To set up furniture as required for visitors in meeting rooms (this may require moving furniture between floors)

Pantry duties

- To laying, clearing and serving in the dining room.
- To setting and clearing of coffee and tea breaks
- To washing up and putting away of dishes.
- To cleaning of pantry area
- To follow food hygiene requirements

Laundry duties

- To collect and bag dirty laundry ready for collection.
- To monitor and store clean laundry and ensure it is allocated to the appropriate area (eg First floor, Second floor and Coach House Cottage)
- To wash, iron and store House laundry
- To liaise with the laundry service to ensure timely collection and return of clean laundry according to the room booking needs of the house.

Other Duties

- To assist visitors and ensuring their safety and welfare
- To assist with the general running of the house
- To supervise casual staff with house keeping duties
- Any other duties that might be reasonably required from time to time

The main duties and responsibilities of your post are outlined in your job description. This list is not exhaustive and is intended to reflect your main tasks and areas of work. Changes may occur over time and you will be expected to agree any reasonable changes to your job description that are in line with the general nature of your post. You will be consulted about any changes to your job description before these are implemented.

Health and Safety

Under the Health and Safety at Work Act 1974, whilst at work you must take reasonable care for your own health and safety and that of any other person who may be affected by your acts or omissions. In addition, you must co-operate with the Charity on health and safety issues and not interfere with or mis-use anything provided for your health, safety and welfare.

Annualised Contract/Holiday Entitlement

Shepherds Dene operates on annualised hours contracts. The hours for this post are based on a 30 hour week over a 52 week period.(1560 hours).

Holiday entitlement is 150 hours holiday and 48 hours bank holidays which is subtracted from the total. The contracted working hours are therefore 1362 hours per year.

On occasions you may be required less than your contracted hours. You will be required to work those contacted hours at other times according to the needs of the business.

You may be required to work more hours than your contracted hours per month to cover peak business periods, staff holidays or staff illness and training.

<u>Pension</u>

You will be admitted to the Shepherds Dene Stakeholder Pension Scheme.

Working Hours

Shepherds Dene is a Retreat House which provides accommodation to residential and day guests throughout the year. The housekeeping role will be largely undertaken Monday to Friday but with occasional requirements for weekend work when time off in lieu will be given.
